Board Treasurer:

This position is open for nomination.

Ordinary Member: One (1) Ordinary Board Member position is open for nomination.

Current Board Members

President, Colin Oates (Offpeak 4WD Club) was appointed by the Board to be President in March 2020. Colin's term of office ends at the 2021 AGM.

Curriculum Vitae (CV)

Provide a written CV with your nomination form.

Reference

Provide a written reference from your Club President, Committee or other suitable organisations or persons to support your nomination.

Candidate Statement

In support of your nomination, you are required to submit a candidate statement. Your candidate statement forms part of your nomination and must be received before nominations close. The purpose of the statement is to assist members at the Annual General Meeting in making an informed choice of candidate. Should the number of candidates exceed the number of positions available on the Board a ballot will be conducted.

Candidate statements must be no more than 250 words long and may include: age; personal and family information; recognised educational attainments and qualifications; details of your professional experience; memberships of associations, clubs and community organisations; relevant non-professional experience; your reasons for seeking to join the Board of Four Wheel Drive Victoria, and the professional skills and knowledge you would contribute.

All candidate statements will be printed in the same type, format and layout for distribution to voting members at the AGM. Statements over 250 words in length will be edited by Four Wheel Drive Victoria. Statements should also be limited to the presentation of an individual candidate's merits and must not contain representations regarding other persons.

Statements may be written in either the first person or the third person (as in the sample below). If you would like a photograph to be included with your candidate statement, please submit a recent (not more than 12 months old) passport style photograph. To safeguard against errors, only word-processed statements are to be submitted, (single page only). All Board nomination documents must be sent to Four Wheel Drive Victoria, Board Secretary, at the FWDV office - <u>office@fwdvictoria.org.au</u>.

BOARD POSITION OVERVIEWS

President

The President is responsible for leadership of the Board, for an efficient association, conduct of the Board's function and the briefing of all board members in relation to issues arising at board meetings. The President is also responsible for arranging Board performance evaluation.

The President's role is to:

- provide leadership for the Board and chair Board meetings
- ensure the effectiveness of Board meetings
- ensure board members act in accordance with the Rules and relevant laws
- ensure that all new board members undergo an appropriate induction program
- together with the Secretary, establish an annual Board calendar which ensures that the Board undertakes all its key responsibilities throughout the year
- establish the agenda for Board meetings in consultation with the CEO and Secretary
- together with the CEO and Secretary, ensure that appropriate Board papers are prepared on all matters for consideration and decision at Board meetings and that such papers are circulated in advance
- chair Annual General Meetings and special general meetings of members, and be the spokesperson for the association at Annual General Meetings.

Vice President

The role of the Vice President is to assist the President in performing their role, particularly with regard to governance matters. In addition, the Vice President fulfils the responsibilities of the President in the event that the President has temporarily vacated their position or is not present at a meeting of the Board.

Secretary

The Secretary is responsible for advising the Board on governance matters and ensuring there is a system of governance and compliance in place for FWDV. The Secretary ensures that FWDV meets its statutory obligations. The Secretary works in conjunction with the President to manage the smooth functioning of the Board by managing Board processes and ensuring Board meetings are properly held and called and appropriate records are maintained. In particular, the Secretary is responsible for maintaining appropriate records, registers and minutes.

Treasurer

The Treasurer is responsible for advising the Board on finance and accounting matters. The Treasurer ensures there is a system for management of finance and accounts of the Association, which meets all statutory and compliance requirements regarding financing and accounting. Presenting financial reports to the Board and meetings of the Association are the Treasurer's responsibility.

Ordinary Board Members

The role of an Ordinary board member is to participate in the governance of FWDV, assist the Board to fulfill its role and functions of strategic oversight and ensure FWDV activities are aligned with associational purposes and objectives.
