The meeting opened at 7:44 pm

- 1. Quorum: With 45 of the 101 delegates entitled to vote being in attendance physically or by proxy it was determined that a quorum in excess of the required 10% was present.
- 2. Colin Oates (Off Peak 4WD Club), as Vice President of the Association conducted the meeting after having tendered the apologies of the President, Michael Martin (Toyota Land Cruiser Club) who was unable to attend.
- 3. Minutes of the previous annual general meeting were accepted as read. Moved: Michael Podolak (Toyota HiLux 4WD Club of Vic.), Seconded: Joe Grosz (Werribee District 4WDClub).
- 4. Reports: Financial statements of the Association for the preceding financial year were presented by the Treasurer, Doug Mitchell (Off Peak 4WD Club), in accordance with Part 7 of the Act and Board reports on activities during the year delivered by Colin Oates and CEO, Wayne Hevey (Just Mates 4WD Club) were considered and accepted. ### **Delegate Definition**

**Delegate:** is a person from an affiliated club who may act/vote for that club at a general meeting. Affiliated clubs may have more Delegates than their voting entitlement. Each club's President, Vice-President, Secretary, Treasurer and an elected Delegate, if there is such a position on committee, is deemed to be a Delegate. Other persons from the club may be nominated as Delegates by the club's committee in writing in the form set out in Appendix 3 or in such form as may be prescribed by the Board from time to time - Rule 4.

**Appointment of Proxy:** A registered delegate entitled to vote may appoint another member entitled to vote as a proxy, to vote and speak on his or her behalf at the general meeting. The form for the appointment of a proxy approved by the Board for this meeting is included with this notice [Rule 34(5)(b)].

#### **Discussion and asking questions**

Members will have a reasonable opportunity to ask questions at the meeting. However, questions should be as brief as possible and relevant to the matters being discussed.
